1. WTO/ Geographical indications

- WTO, Trade Negotiations Committee (TNC, http://www.ige.ch/E/jurinfo/j1101.shtm#4), 30th June, 2004. The Ambassador Luzius Wasescha, Delegate of the Swiss Federal Council to Trade Agreements, indicated in his declaration made on behalf of the Group of the Friends of Geographical Indications that the improvement of the protection of geographical indications is to be appropriately reflected in the decision that WTO Members are supposed to adopt by the end of July. For the Group that counts more than 50 Members of the WTO, among which many developing countries it is essential that the extension of the protection of Article 23 TRIPS Agreement to all products is part of the outcome of the Doha Round. Switzerland shares this preoccupation. For years, the Institute has been actively engaged in the promotion of geographical indications.
