1. Discussion of co-operation within the European Patent Organisation under the Patent Cooperation Treaty

In the context of recent developments, such as the introduction of the ISO by WIPO or the granting of ISA status to the Finnish Office, the Administrative Council of the European Patent Organisation has decided to launch a strategy debate on co-operation within the Organisation under the PCT at its June 2004 meeting. 2. Electronic Priority Documents for Patents from the United States Patent and Trademark Office (USPTO)

As of July 30, 2004, the United States Patent and Trademark Office (USPTO) only provides priority documents for patents as electronic files with an imaged certification statement. All other types of priority certificates are still issued in paper form. For the time being, the Institute will not accept electronic priority certificates.

An overview of all of editorials and court decisions published by sic! (the Swiss journal for intellectual property, information and competition law) since 1997 can be found at http://www.sic-online.ch/. All of the court decisions as well as any issues published since January 2000 have been collected in an index ("Register of Decisions" or "Bibliography"). A new tool allows searching with key words or author names. Also new is that decisions which appeared in sic! print only as topic sentences are now available in full text at sic! online.

Subscribers to Swisslex-Westlaw, the legal database, can now go directly to the full sic! text from sic! online.

sic! online is published only in German or French.

5. WTO/ Geographical indications

On geographical indications, the main results to report from the General Council "July package" decision (agreed on 1 August 2004) are that the Director General of WTO was mandated to continue consultations on the extension of the protection of geographical indications provided for in Article 23 of the TRIPS Agreement to products other than wines and spirits; further, WTO Members reaffirmed their commitment to progress in the negotiations on the establishment of a multilateral register for geographical indications for wines and spirits.
