1. Legal opinion

2. Adequate patent protection for inventions in the field of biotechnology

At its session of November 23, 2005 the Federal Council adopted the legislative message on the revision of the patent law. The revision adapts the patent law to the technological progress and the international developments of the past years. Its main focus is to ensure an adequate patent protection for inventions in the field of biotechnology. This revision is the second part of three of the patent law revision. See the press release in
