

Patent Register Search

Information on protective titles effective in Switzerland and abroad

If you would like to know whether a protective title published in Switzerland or abroad is still in force or who the current owner is, we can provide you with the information you need.

Information about CH patents

The patent register can be searched by any interested parties. It contains bibliographic and legal status information regarding all CH protective titles. It includes Swiss patents and published Swiss patent applications, European patents and patent applications designating Switzerland and Liechtenstein (EP)*, international patent applications for Switzerland (PCT)*, supplementary protection certificates (SPCs) and SPC applications.

Searches

We search all published CH protective titles for the information you need based on your search criteria:

- A **Legal Status Search** provides information on whether a CH protective title is still in force, who the owner is and whether it has been transferred. This indicates whether an invention is freely available and helps avoid patent infringements.
- A **Name Search** provides information on all the CH protective titles belonging to a certain owner or inventor. Such information is useful, for example, in evaluating the technology activity and R&D strategy of a competitor, avoiding patent infringement, or determining areas of potential collaboration.
- A **Priority Search** uses a priority number from any country and shows whether, as part of a patent family, a parallel CH patent has been applied for or granted.
- An **SPC Search** provides information about whether a supplementary certificate of protection or application for such exists for a certain CH or EP patent or chemical compound (an SPC extends patent protection for pharmaceuticals and pesticides up to five additional years).

Further kinds of searches based on the available data are possible.

Results

You receive a results list with the patent number and title of all matching protective titles and/or a search report with bibliographic and legal status data for each result.

The bibliographic information includes patent and priority numbers, dates for priority, filing and granting, name of the owner, inventor or representative, information on any transfers, title of the invention, and the patent classification. The legal status information includes whether a patent is still in effect or if it has been cancelled.

Cost-free information

- Our online database at www.swissreg.ch includes information on published CH applications and granted CH and EP patents designating Switzerland and Liechtenstein.
- Or you can contact us by telephone: We provide information about published titles over the phone at no cost based on the filing, priority or publication number.

Information on protective titles with effect abroad

If you would like to know the legal status of a protective title with effect abroad, we can direct your query to the appropriate foreign patent office for the same fee. We will forward the response to you as we receive it.

Fees: Min. CHF 90.00 per search; if the search takes more than one hour, every additional hour is billed at CHF 180.00 (prices including VAT) (Art. 3 para. 2 of the IPI Fee Ordinance).

Delivery: As agreed; normally within 5 working days.
