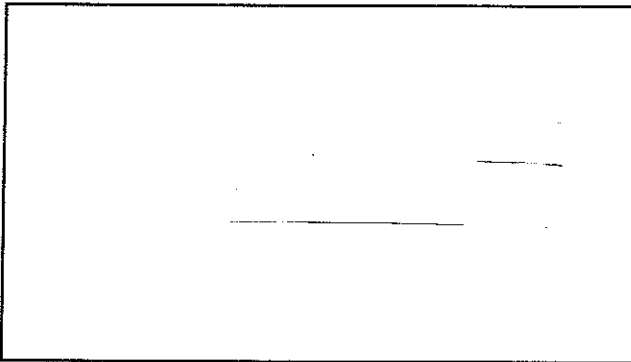

General terms of contract and trade

§ 1 Legal basis:

The International Mark has been published in the WIPO-Gazette, which is edited by the Bureau of the World Intellectual Property Organization. This publishing forms the basis of our offer. Accepting the offer, your international trademark is stored, and/or the company-referring data to the trademark holder. You may cancel this contract without any penalty or obligation within 3 business days from the above date, and receive a full refund of all payments made to the seller. You may also cancel this contract if upon a doctor's order you cannot physically receive the service, or you may cancel the contract if the services cease to be offered as stated in the contract. If you cancel the contract for either of these reasons, the seller (IOPTS LLC.), may keep only a portion of the contract price equal to a pro rata portion of the total price representing the proportion of services you used or completed, plus the cost of the seller of any related goods which you have consumed or retained.

§ 2 Purpose of the registration:

The purpose of the registration is for one to be able to obtain access to our data files for fast information about foreign international trademarks as well as their holders, so you can eventually improve your position in competition. Secondly, it is the purpose of registration to eventually improve your communication possibilities in competition. To fulfill this task or make it easier, our data banks with international trademarks, besides entries about their holders, are at your disposal which are enlarged, actualized, and eventually also modified from day to day. The entitled to benefit person has in principle cost-free access to our data base. § 4 Registration period:

Your registration as an entitled person to benefit from IOPTS services is made after receipt of payment. In case of payment per cheque, the day of cashing is valid as payment day.
